
**OFFICE ORDER**

In supersession of all Office Orders issued earlier in this regard, a revised list of designated Central Public Information Officers (CPIOs) for providing information in respect of the subject matters mentioned against their names and First Appellate Authorities (FAAs) to consider and dispose of First Appeals in respect of the subject matters mentioned against their name as per **Annexure-I** attached with this order.

2. Further, it may also be intimated that in case the particular CPIO/ FAA is on leave/tour, the deputed link officer will handle or dispose of the RTI/Appeal cases and if the CPIO / FAA is transferred/retired, in that case the RTI work automatically will be deemed to have been assigned to the new incumbent in his / her place. It is also intimated that the SO/SSO/equivalent officer dealing with the subject matter under respective CPIOs will act as CPIO in the absence of CPIOs for disposal of the RTI-related cases.
