

# **Expression of Interest (EOI) for Procurement of Thermal Scanners**

## **Subject: Invitation for Expression of Interest (EOI) for the Supply and Procurement of Thermal Scanners for Public Health Screening Purposes**

### **1. Introduction**

The Directorate General of Health Services (DGHS), Ministry of Health and Family Welfare, Government of India, invites **Expression of Interest (EOI)** from reputed manufacturers, authorized suppliers, and agencies for the **supply and installation of thermal scanners** at international Points of Entry (PoEs) including airports, seaports, and land crossings to detect elevated body temperatures which may indicate potential infections, supporting efforts during health emergencies like COVID-19 or Mpox outbreaks. The goal is to implement an efficient screening process that can quickly identify potentially unwell individuals for further assessment, thereby helping to contain the spread of infectious diseases.

### **2. Purpose of this EOI**

This EOI aims to gauge market interest and gather information from capable firms regarding the supply, installation, and maintenance of thermal scanners that meet specific requirements. Responses will help [Name of Issuing Organization] to understand the available technologies, solutions, and potential partners for a possible future procurement process.

### **3. Scope of Requirement:**

We are interested in thermal scanning solutions that utilize infrared technology to measure body temperature quickly and non-invasively. The system should be suitable for screening individuals in settings like airports, triggering alerts for elevated temperatures to notify relevant personnel, without causing any disruption to flow of passengers.

### **4. Key Specifications:**

Interested firms should offer thermal scanners that meet the following specifications:

#### **Essential Requirements:**

- Thermal Sensitivity: Must be less than 50mK (< 50mK\$).
- Image Resolution: Must provide good/high image quality suitable for the intended screening purpose.
- Facial Recognition: Must include integrated facial recognition features.
- Data Management: Must have the capability to store event data (e.g., scans, alerts) and incorporate an effective alert system.
- Data Export: Must provide a facility to export stored data.

**Desirable Requirements:**

- Preference may be given to solutions that also offer:
- CAMC Inclusion: Option for a Comprehensive Annual Maintenance Contract.
- Connectivity: Wired internet connectivity options for network integration or data transfer.

**5. Information Requested from Interested Firms:**

Firms wishing to express their interest should provide the following information:

- A brief company profile, including relevant experience in supplying similar equipment.
- Detailed product brochures and technical specification sheets for the proposed thermal scanner model(s).
- A clear statement confirming how the proposed product(s) meet each of the essential requirements listed in Section 4a.
- Information regarding the availability and details of the desirable requirements (CAMC, wired connectivity) mentioned in Section 4b.
- Description of the data storage capabilities, alert system functionality, and data export mechanisms.
- Information on warranty, installation support, user training, and after-sales service offered.
- (Optional) Indicative pricing or pricing structure.
- (Optional) Details of any relevant certifications or past projects/client references.
