The undersigned is directed to say that the Port Health Organizations/Airport Health Organizations/Land Border Quarantine Centers [PHOs/APHOs/LBQCs] under Directorate of General of Health Services (MoH&FW), requires 5 (five) posts of Health Inspector to be filled on deputation basis in the pre-revised scale of Rs.9300-34800 plus Rs 4200/- Grade Pay (Pay Band-2) replacement Pay Level-6 (Rs. 35400-1,12,400) in the Pay Matrix in 7<sup>th</sup> CPC from amongst persons working in the Central Government or State Government or Union Territory administration or Autonomous or statutory organization or Public Sector Undertaking or Universities or recognized research institutions at the following Point of Entries (PoEs):


