

ORDER

In pursuance of Department of Personnel & Training's Gazette Notification No.G.S.R.767 (E), dated 11th August 2018 regarding amendment of FR 56 (bb), an Office Memorandum No.A.12034/4/2018-CHS.V, dated the 13th August, 2018 along with the approved option format, was circulated to all participating units for exercising options by the doctors of Central Health Service who have already attained or attaining the age of 62 years for their further posting depending on the field of their expertise/experience, in case they desire to continue in the service upto the age of 65 years.

2. Dr. Sunita Mondal, Addl. DGHS (Physiology) has opted for continuing her service after attaining the age of 62 years on 08.01.2026 with Teaching as first option.

3. Dr. Sunita Mondal, Addl.
