

OFFICE ORDER

Whereas, Department of Personnel and Training's Notification No. G.S.R. 27(E) published in Gazette of India dated 05.01.2018 regarding amendment of Rule 56(bb) of the Fundamental Rule, 1922 stipulates that age of superannuation in respect of Officers of General Duty Medical Officers (GDMO) sub-cadre of Central Health Service (CHS), among others, shall be sixty-five years, provided that such officers shall hold the administrative posts till the date of attaining the age of sixty-two years and thereafter their services shall be placed in non-administrative positions.

2. And whereas, DoPT's Notification No. G.S.R. 767(E) dated 11.08.2018 regarding amendment of Rule 56(bb) of Fundamental Rule, 1922 read with this Ministry's OM No. A.12034/4/2018-CHS.V dated the 13th August 2018 provides that the age of superannuation in respect of CHS Officers shall be sixty-two years, unless they exercise the option of posting as prescribed therein, in case they desire to continue in their services up to the age of sixty-five years.

3. And whereas, Dr. Vijaya Vijay Motghare working as Additional Director General of Health Services in Directorate General of Health Services, is going to attain the age of 62 years on 04.10.2025 and the Officer has exercised option for posting to non-administrative post under CGHS Nagpur on attaining the age of sixty-two years vide Office of Addl. DGHS(VM) Note dated 01.04.2025.

4. And whereas, the option exercised by the Officer for continuing in service beyond 62 years, on attaining the age of sixty-two years on 04.10.2025 has been considered by the competent authority in the Ministry.

5. Now, therefore, with the approval of the Competent Authority, Dr. Vijaya Vijay Motghare is hereby allowed to continue in service beyond sixty-two years, and her services are placed in non-administrative post w.e.f. 04.10.2025 and she will be posted as Sr. CMO (SAG) under CGHS Nagpur. Charge relinquishment/assumption report in respect of the officer may be obtained and sent to the Ministry at the earliest.
